Annual Monitoring for Patients on Persistent Medications

Patients with an active prescription of digoxin should have a serum potassium and a serum creatinine test or a serum potassium and a blood urea nitrogen test at least yearly.
 Patients with an active prescription of a diuretic should have a serum potassium and a serum creatinine test or a serum potassium and a blood urea nitrogen test at least yearly.
 Patients with an active prescription of an ACE or ARB should have a serum potassium and a serum creatinine test or a serum potassium and a blood urea nitrogen test at least yearly.
 Patients with an active prescription for an anticonvulsant should have a corresponding drug level checked at least yearly.
