Encounter Date(s): Jan 1, 2015 through Dec 31, 2015
Report Criteria: Patients 65 And Older

Medication Review - Medication assessment and reconciliation should be completed at least yearly.

Functional Assessment - A functional assessment should be completed at least yearly.

Pain Screening - A pain screening should be completed at least yearly.

High Risk Medications - Patients who have an active prescription of (a) one or (b) two or more medications which are considered high-risk for use in the elderly.

Glaucoma Screening - A dilated eye exam should be completed at least yearly.
